Our fully automated carbonated beverage canning line, commissioned in August 2024, runs at an optimal speed of 9,000 cans per hour, allowing us to accommodate shorter production runs without sacrificing efficiency or quality.

For brands that don't meet the high minimum order quantities required for printed cans, we offer on site sleeving using our in-house sleeving tunnel. This provides a cost effective, full body branding solution using bright (blank) cans.
